WHEREAS, we the undersigned owners of the hereinafter described property are desirous of placing certain restrictive covenants on the use of said property which is located in Putnam County, Florida, described as:

NOW, THEREFORE, THESE PRESENTS WITNESSETH: That the parties of this agreement do herein and hereby covenant and agree for themselves, their heirs, successors and assigns, that the following covanants and restrictions are hereby placed upon the property above described:

- l. There shall not be erected on said premises any buildings or structure other than a one-family dwelling and accessory buildings such as garage, garden house, ground improvements and the like to be used by the family and guest occupants of said dwelling; no garage or temporary building shall be used or occupied as living quarters, except that part or portion of a garage building may be designed and occupied as employee quarters.
- 2. We building shall be erected nearer than 33 feet to front line of said premises or nearer than 5 feet of any side line or 10 feet of any rear line; no fence, wall, or hedge shall be erected or maintained exceeding five (5) feet in height.
- 3. We dwelling shall be erected or maintained on said premises having a living space of less than 1200 square feet exclusive of garage and accessory buildings. Use and occupancy of the premises shall be subject to building, health, sewage disposal and sanitation regulations and laws of the State of Florida, and all Government agencies having jurisdiction theseof.
- 4. We house trailers will be allowed to park on property for storage or residential purposes.
- 5. We residential structure shall be erected or placed on any building plot, having an area of less than 8000 square feet, nor less than 70 feet at the front building set-back line.
- 6. All residential structures to be placed on any building plot shall conform in design and exterior appearance to the general character of the neighborhood.
- 7. Rutbish and garbage must be kept in suitable containers and removed from premises in accordance with samitation regulations. No rubbish or garbage may be burned or dumped on said premises.
- 6. Purchaser shall coumit no nuisance and shall suffer no nuisance to be committed by his guest or invitees. No noxious or offensive trade or activity shall be carried on upon any lot.
